Instant Search

Search owner name, address and city. As you type results will appear similar to Google instant search. Click the name in the list to be taken to the data view.
 For example to find Mr Smith on Jones Street type **smith jones**.
 or to find Mr Jones on Smith Street type **jones smith**. The results will be different as terms are prioritized. Owner names get top priority over address and city names
 Usually you will not need to finish the last word
 Press the Enter key after a copy and paste or a block deletion.
